

**Devon County Council (Butcher Park Hill, Tavistock)  
(Restricted Road & 30mph Speed Limit) Order**

Devon County Council under the Road Traffic Regulation Act 1984 propose to:

**EXTEND** the 30mph speed limit by virtue of street lighting (**RESTRICTED ROAD**), from a point 16 metres north of the centre-line of its junction with Redmoor Close northwards until a point 146 metres south of the centre-line of its junction with the access road to Embden Grange development (Crebor Road)

**INTRODUCE** a 30mph speed limit on Butcher Park Hill from a point 146 metres south of the centre-line of its junction with the access road to Embden Grange development (Crebor Road) northwards until a point 178 metres north of that junction

**Statement of Reasons**

The proposed extension to the 30mph speed limit is considered necessary to reduce the speed of traffic adjacent to the new residential development scheme at Embden Grange off Butcher Park Hill, Tavistock. This is to improve road safety for all road users in the area. The extension will include a length of restricted road (30mph by virtue of new street lighting) and 324 metres of 30mph speed limit beyond the extent of the streetlighting.

Specifically, the orders will avoid danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising and to preserve or improve the amenities of the area through which the road runs.

Devon County Council make the following order in exercise of powers under sections 82, 83, 84 of the Road Traffic Regulation Act 1984 ("Act") & of all other enabling powers

- 1 This order comes into force \_\_\_\_\_ and may be cited as "Devon County Council (Butcher Park Hill, Tavistock ) (Restricted Road & 30mph Speed Limit) Order \_\_\_\_\_"
- 2 The length of road specified in schedule 1 is a restricted road for the purpose of section 81 of the Act
- 3 No person shall drive any motor vehicle at a speed exceeding 30mph on the length of road specified in schedule 2
- 4 No speed limit imposed by this order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011

*Length of road at Tavistock in the district of West Devon*

Butcher Park Hill, from a point 16 metres north of the centre-line of its junction with Redmoor Close northwards until a point 146 metres south of the centre-line of its junction with the access road to Embden Grange development (Crebor Road)

**Schedule 2      30mph Speed Limit**

*Length of road at Tavistock in the district of West Devon*

Butcher Park Hill, from a point 146 metres south of the centre-line of its junction with the access road to Embden Grange development (Crebor Road) northwards until a point 178 metres north of that junction

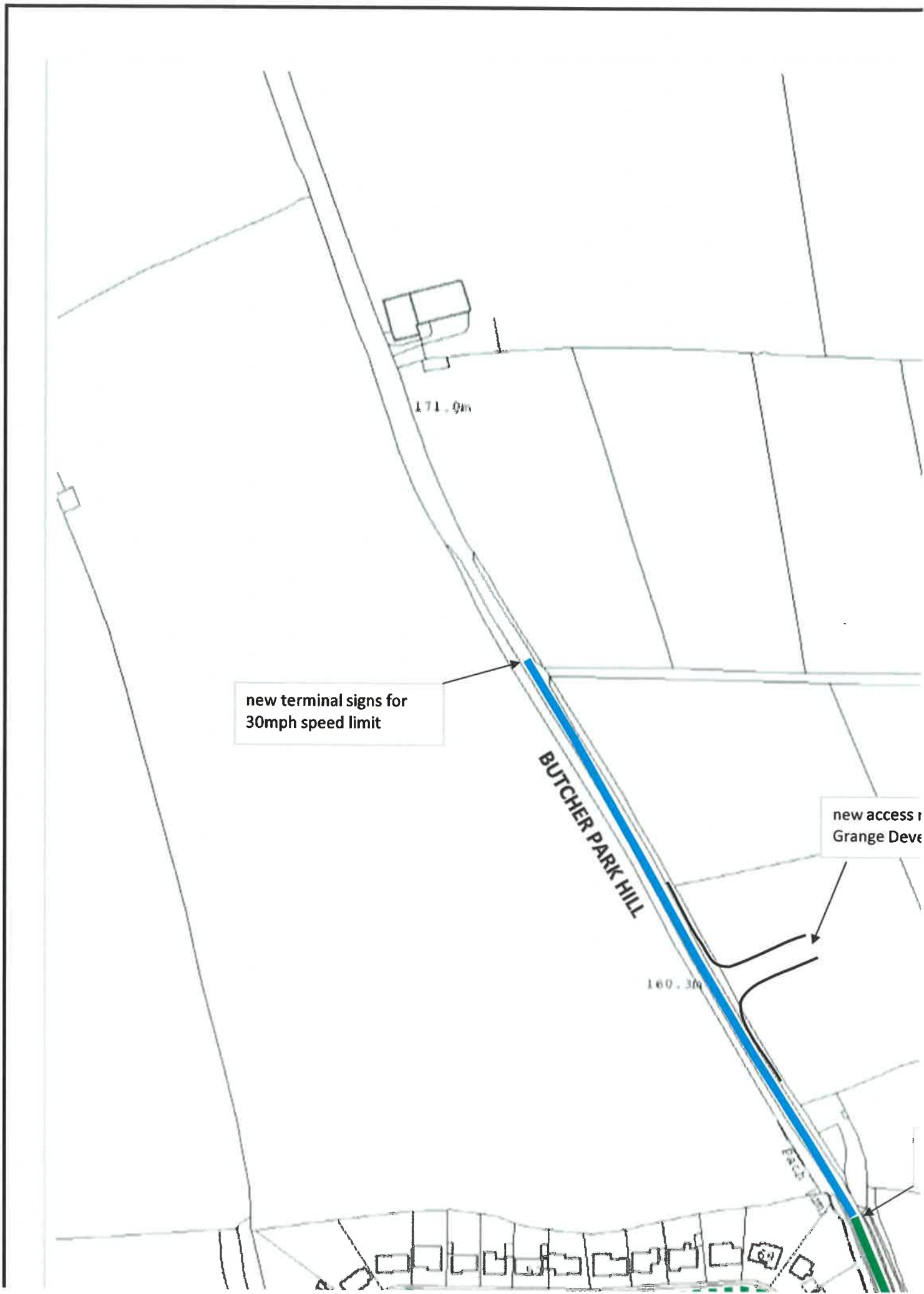
