**Next Steps**

At the Authority meeting on the 3 December DNPA Members will be asked to consider the Inspector's Report, accept the Modifications and adopt the Local Plan. Papers for this meeting will be published [here on our web site](#) Friday 26 November, along with a final text version of the Local Plan, incorporating the main and additional modifications. Once it is adopted, the Local Plan will have immediate effect, superseding the outgoing plans and being used as the basis for all planning decisions in the National Park.

We will notify you again when the Plan is adopted, sharing with you at that stage further information on final steps. In particular we are planning a training event with Parish Councils and an event for agents/architects, we will publish a Quick Guide to the Local Plan, and prepare a final designed version.

We thank you again for your contributions to the review of the Local Plan, and the examination, and look forward to working with you delivering its vision. More information will follow shortly, if in the meantime you have any questions please do contact me, or Alex Gandy.
