If your community does not now require a grant, please contact me as soon as possible so that these funds may be made available to other communities.

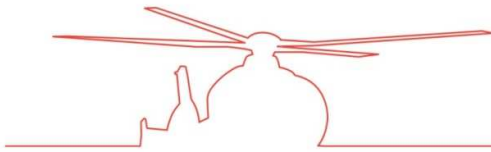
