We note that DCC has chosen to ignore our client's repeated objections and clear reasoning about why the proposals will not benefit Tavistock. We reference our client's letters of 5 October 2023 (the letter addressed to Councillor Hughes, the letter addressed to Mr Rook and the letter addressed to Ms Booth) and our client's letter of 4 January 2024 addressed to Mr Rook.

We look forward to receiving full disclosure of your communications and documents relating to your proposals in response to our EIR request by 12 February 2024.

1. Consultation Period

We thank you for confirming the advertising period. Our client sent further objections on 4 January 2024 in a concise electronic response on your consultation site and a full response by letter sent to Mr Rook. Our client received a read receipt dated the 4 January 2024, confirming that you received these further objections within the advertisement period.

At the "informal consultation including an in person meeting held with the Town Council, West Devon Borough Council and Tavistock BID on 11th September 2023" our client was asked to respond to your proposals by 9 October 2023, which it did.

2. Failure to consider section 122 and section 45 Road Traffic Regulations Act 1984

Our client has clearly set out why your proposals fail to apply these sections in its various letters of objections. You have failed to disclose any analysis, evidence, data or records (or
