Accessibility Statement

This website is run by Tavistock Town Council. We want as many people as possible to be able to use this website. For example, that means you should be able to:

- Change colours, contrast levels and fonts
- Zoom in up to 300% without the text spilling off the screen
- Navigate the main headings of the website using just a keyboard
- Navigate the main headings of the website using speech recognition software
- Listen to most of the website using a screen reader (including the most recent versions of *JAWS*, *NVDA* and *VoiceOver*)

How accessible is this website?

- The text will reflow in a single column when you change the size of the browser window
- All pages on the website will zoom to 300%
- Contrast levels and colours can be changed
- Main headings are accessible when using a keyboard
- Online forms are relatively easy to navigate using just a keyboard

We know some parts of this website are not fully accessible:

Tavistock Town Council is committed to making its website accessible, in accordance with the Public Sector Bodies (Websites and Mobile Applications) (No. 2) Accessibility Regulations 2018.

Compliance status

This website is partially compliant with the Web Content Accessibility Guidelines version 2.1 AA standard, due to:

Non-accessible content

Non-compliance with the accessibility regulations

The content listed below is non-accessible for the following reasons:

- Some videos that we link to are not captioned, or may rely on auto generated captions and may not be completely accurate (for example linking to YouTube from our Meetings Page);
- Some images do not contain "alternative text" especially on our Gallery Pages.
 - o This fails WCAG 2.1 success criterion 1.1.1 (non-text content).
 - We plan to add text alternatives for all images we publish moving forward to meet the accessibility standards, with the exception of Gallery images (see Disproportionate burden below).
- PDF and Word documents since 23rd September 2018 may not meet accessibility standards, for example, they may not be structured so they are accessible to a screen reader, or do not contain headings and some are scanned documents.
 - This fails WCAG 2.1 success criterion 4.1.2 (name, role value)
 - Any new PDFs or Word documents we publish will meet accessibility standards as far as possible and we are developing accessible templates for Agendas, Minutes and Reports.

Navigation and accessing information

- There's no way to skip the repeated content in the page header (for example, a skip to main content' option).
 - This fails WCAG 2.4 success criterion 2.4.1 (Bypass Blocks)
- "Errors Empty button" A button is empty or has no value
 - This fails WCAG 2.4 success criterion 2.4.4 Link Purpose (In Context)
 - o We are working with our website provider Cosmic to correct these errors.
- "Errors Empty link" A Link contains no text
 - This fails WCAG 2.4 success criterion 2.4.4 Link Purpose (In Context)
 - We are working with our website provider Cosmic to correct these errors
- "Contrast Errors" Very Low Contrast between foreground and background colours
 - This fails WCAG 1.4 success criterion 1.4.3 Contrast (Minimum)
 - We are working with our website provider Cosmic to correct these errors

It is not always possible for all our content to be accessible, however, we will always strive to ensure that it is. If we have failed to ensure an element is accessible, please contact us (see Contact Us above).

Disproportionate burden

- Images
 - This fails WCAG 2.1 success criterion 1.1.1 (non-text content)
- PDF'
 - This fails WCAG 2.1 success criterion 4.1.2 (name, role value)

We've assessed the cost and time involved with fixing the issues with navigation and accessing information with interactive tools. We believe that doing so now would be a disproportionate burden within the meaning of the accessibility regulations.

Content that is not within the scope of the Accessibility Regulations PDFs and other documents

Some of our PDFs and Word documents are essential to providing our services. For example, we have PDFs with information on how users can access our services, and forms published as Word documents.

The accessibility regulations do not require us to fix PDFs or other documents published before 23 September 2018 if they're not essential to providing our services. For example, we do not plan to fix:

We do not plan to add captions to live video streams because live video is exempt from meeting the accessibility regulations.

What we are doing to improve accessibility

Lessons learned from this report will be taken forward when we next do a major redevelopment of the website. The issues identified in this Document/Report are being resolved actively.
