3. Ice Cream Pitch Tender

As previously reported, the previous Licence for the Ice Cream pitch in Guildhall Car Park expired on 30th September 2019. A Tender exercise was therefore undertaken.

6. Property Units - Update

Residential - there were previously two vacant residential properties;

<u>2 Market Road</u> - the refurbishment of this property is now complete, with the unit currently being marketed. A viewing is due to take place week commencing 24th February 2020.

<u>Cemetery Lodge</u> - the refurbishment works to this property are also complete. A new tenant moved in with effect from Friday 14th February 2020.

<u>Flat at 15 Duke Street</u> – notice has been given on this flat, once available any necessary refurbishment works will be undertaken, prior to marketing the unit.

Commercial - there are currently two vacant commercial properties;

<u>15 Duke Street</u> – the position on this property remains as previously reported in that there is still a Lease in place, as a Break isn't available until November 2020. The existing tenant is therefore liable for rent, and to pay utility bills etc until that date. We are however aware that they are currently looking for a new tenant to have the Lease assigned to, which will require consent.

<u>2 East End Stores</u> - as previously reported, the Council accepted a request allowing the vacating of this commercial unit. The organisation involved subsequently requested to stay in the unit until 7th March 2020. The unit is currently being marketed.

<u>5 East End Stores</u> – as Council will be aware, a Break Clause was invoked on this unit, and it became available on 15th February 2020. An expression of interest has been received with a viewing taking place on 26th February. If an update is available, it will be provided at the Meeting.
