### 1. ELECTION OF MAYOR

A nomination was received in respect of Councillor P Sanders (proposed by Councillor Mrs M Ewings and seconded by Councillor Mrs A Johnson).

There being no other nomination it was:

RESOLVED THAT Councillor P Sanders be elected Mayor of Tavistock Town Council for the 2017-18 Civic Year.

The Mayor was invested with the Chain of office. He signed the Declaration of Acceptance of Office and thanked the Council for the opportunity to represent it as Mayor.

Councillor C Rogers gave a tribute to the retiring Town Mayor Councillor Mrs M Ewings.

Retiring Mayor, Councillor Mrs M Ewings, expressed her appreciation to colleagues and staff for their support and endeavours over the past Civic Year together with those other partner organisations and community groups with whom she had been associated. Tribute was also made, in particular, to her Deputy Mayor – Councillor P Sanders.
