### 141. GENERAL CORRESPONDENCE

a) BT Payphone Kiosk Removal – a 90-day consultation regarding the removal of 28 public phone boxes in West Devon will conclude on 24<sup>th</sup> December 2016. Members had been invited to give feedback, which would be included with West Devon Borough Council's draft decision to the Secretary of State and BT (Appendix 2)

Following a discussion regarding the level of usage of the boxes located in Tavistock, and their individual locations, it was;

RECOMMENDED THAT Tavistock Town Council 'object' to the removal of the payphones located at;

- Tavy Road, Tavistock and
- Junction of Callington Road/Plymouth Road

This was due to the level of usage over the last 12 months, however it was further RECOMMENDED THAT the Town Council 'support' the removal of payphones at the following locations;

- Crelake Park, Tavistock
- Bannawell Street, Tavistock
- Anderton Lane, Whitchurch

The above recommendation again related to the level of usage of these particular payphones over the last 12 months.

The Plans Committee restricted their comments to only those payphones within Tavistock.

West Devon Borough Council was notified of the above RECOMMENDATIONS as a draft response, to meet the first deadline for feedback, pending ratification at the Full Council Meeting due to be held on 15<sup>th</sup> November 2016. West Devon Borough Council will be notified of the Town Council's decision on the proposals following that Council Meeting.
